TERMS AND CONDITIONS

1. The terms of this initiative must be read in conjunction with the StartSomeGood Terms and Conditions located here <https://startsomegood.com/terms>.
2. The Funds provided by SERVICE ONE are a SPONSORSHIP that will be paid directly to STARTSOMEGOOD at the beginning of your campaign into order to catalyse your campaign.
3. You are responsible for raising the agreed target and understand that STARTSOMEGOOD is an 'all or nothing platform' – that is, you must achieve the target or no funds will be paid.
4. [Applications](#) for the SERVICE ONE Social Ventures Catalyst initiative are open until 2 September at 12pm.
5. Multiple applications from the same or related social enterprise are not permitted.
6. Crowdfunding Campaigns will run between October and November 2019 (for 30 days), unless extended at SERVICE ONE's¹ discretion.
7. You are prohibited from submitting applications that (i) infringe, or will cause SERVICE ONE to infringe, the intellectual property rights (or other rights) of any third party, or which include the personal information of any third party; (ii) contains material that is unlawful, obscene, defamatory, libellous, threatening, pornographic, harassing, racially or ethnically offensive; (iii) encourages conduct that would be considered a criminal offence, give rise to

civil liability, breach any law; or (iv) is otherwise inappropriate. SERVICE ONE¹ reserves the right to automatically disregard any such applications.

8. You agree that SERVICE ONE¹ shall have the right to immediately remove any application and disqualify any applicant who has or is suspected of violating any applicable terms and conditions.
9. All decisions will be made by SERVICE ONE¹ with respect to initiative participation and venture catalyst sponsorship amounts are final and no deliberation will be entered into.
10. Sponsored Materials include Existing imagery, audio and video assets associated with the Project. Any imagery, audio or video assets generated by SERVICE ONE (or its associated parties) for the crowdfunding campaign; Text, copy, blog and information updates from project campaign, either on StartSomeGood Venture & Campaign pages or associated Sponsored Party website and published materials.
11. You agree to grant SERVICE ONE a royalty free and non-transferable licence to use the Sponsored Materials on its online properties, including websites, social communications, and customer communications.
12. Successful applicants may use the SERVICE ONE Brand Elements in Australia during the Sponsorship Term in accordance with this Agreement solely for the purpose of performing the obligations of the successful applicant under this Agreement and subject always to SERVICE ONE's direction and approval.
13. 16. On termination: (i) all rights granted to the successful applicant and SERVICE ONE under this Agreement cease; (ii) the successful applicant must cease using SERVICE ONE materials and withdraw all documents displaying the SERVICE ONE Brand Elements
